Membership shall be open to all persons engaged in or in a working relationship with the nursery or landscape business. The term "nursery or landscape business" refers to the production, distribution, installation or maintenance of plant materials including trees, shrubs, vines or other plants having a persistent woody stem or stems, and all herbaceous annuals, biennials or perennials generally used for outdoor planting, by those concerns whose activities are agricultural, horticultural or floricultural, and all allied materials.

# Membership Classifications

1. **ACTIVE MEMBERSHIP** shall be open to firms (whether in the form of proprietorships, partnerships, corporations or other business organizations) which are engaged in the nursery or landscape business within or without the State of Ohio or which are engaged in a business or profession closely allied to the nursery or landscape industry. Not more than one active membership shall be held by any one firm.

2. **INDIVIDUAL PESTICIDE APPLICATOR MEMBERSHIP** shall be open to any person engaged in turfgrass and/or plant maintenance and is certified by the Division of Plant Industry of the State of Ohio as a "Commercial Applicator" or "Limited Commercial Applicator" as stated in categories 6 and 8 of the Pesticide Regulation Section. AN APPLICANT MEETING THE CRITERIA FOR ACTIVE MEMBERSHIP CANNOT APPLY FOR INDIVIDUAL PESTICIDE APPLICATOR MEMBERSHIP.

3. **INDIVIDUAL MEMBERSHIP** (1) shall be open to any person employed by a firm holding an active membership in the Ohio Nursery & Landscape Association; (2) shall be open to any person currently employed full time by a firm/organization not directly engaged in the green goods industry, but employed in a capacity providing green goods related services, i.e. landscaping, grounds maintenance, etc. AN APPLICANT MEETING THE ABOVE CRITERIA FOR ACTIVE OR INDIVIDUAL PESTICIDE APPLICATOR MEMBERSHIP CANNOT APPLY FOR INDIVIDUAL MEMBERSHIP.

6. **RETIRED MEMBERSHIP** shall be open to individuals who have been owners or corporate officers of an ONLA member firm in good standing for at least 10 consecutive years and who are no longer actively employed in the green industry.
